1. On Behalf of the President of India, sealed, item-rate tenders are invited for the following work.

**2. Eligibility Criteria for Issue of Tender Documents –**

Tender documents will be issued only to those who satisfy the following eligibility criteria:

Should have satisfactorily completed the similar composite works comprising Civil, PH, Electrical and other allied works as mentioned below during the last Seven years ending previous day of last date of submission of bids. i) Three similar works each costing not less than 40% of the estimated cost (i.e. ₹ 75.79 Lakhs) (or) ii) Two similar works each costing not less than 60% of the estimated cost (i.e. ₹ 113.68 Lakhs) (or) iii) One similar work costing not less than 80% of the estimated cost (i.e. ₹ 151.58 Lakhs).	i. Certified copy of work orders and completion certificates issued by the authority concerned to establish work experience. ii. Completion certificates for works issued by Private parties shall be supported by TDS (Tax Deducted at Source) certificates.
	<b>Note:</b> i. Similar work shall mean works of <b><u>“Construction of buildings and RCC framed structures, composite contract including Civil and Electrical works”</u></b>	

	ii. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of submission of bids.	
b	The bidder should clearly indicate how they are proposing to carry out the Electrical works of the contract i.e. whether directly or through sub-contractor giving full details & declaration which is binding. The agency who is going to execute electrical works (either main bidder or subcontractor) shall possess valid electrical contractor's license of appropriate class and category issued by Central or State electricity authority.	Certified copy of valid <b>electrical contractor's license</b> (of the primary bidder or sub-contractor) shall be submitted at the time of bidding i.e. along with technical bid.
c.	Should have had average annual financial turnover not less than <b>₹ 56.84 Lakhs</b> i.e., 30 % of the estimated cost of the work during the last three years ending <b>31.03.2018</b> .	Certified copy from chartered Accountant for the Annual financial turnover and balance sheet showing Profit & Loss.
d.	Should not have incurred any loss in more than two years during the last five years ending <b>31.03.2018</b> .	
e.	Should have a solvency of not less than 40% of estimated cost i.e <b>₹ 75.79 Lakhs</b> .	Certified copy of current <b>solvency certificate not earlier than 01.04.2018</b> from any Scheduled Bank.
f.	The bidding capacity of the contractor should be more than <b>₹ 189.47 Lakhs</b> The bidding capacity shall be worked out and declared by the tenderer and enclosed with the request for tender document based on the formula: $(AxNx2)-B$ where, A- Maximum value of work executed in one year during last 5 years at current price level taking into account the work completed as well as work in progress. B- Value of existing commitments and ongoing work to be completed during the next 'N' years at current price level. N- Number of years prescribed for completion of the subject contract for which bids are invited [ <b>N=0.5</b> ]	i. Statement showing the value of existing commitment and ongoing works as well as the stipulated period of completion remaining for each of the works listed to be furnished. ii. Current costing level for value of work may be worked out as mentioned in the note (ii) above.

3. "The tender document may be downloaded from e-Tendering website [www.tenderwizard.com/ISRO](http://www.tenderwizard.com/ISRO) '. Downloading of tender documents alone will not make a tenderer eligible for participating in the bidding. The documents uploaded by the tenderers will be subjected to verification subsequently by Department. If found not meeting the requirement, such offers will be rejected.

4. a) Tenders should be accompanied with Earnest Money Deposit for value specified in Para 1 above, in the form of Deposit at Call receipt/ Term Deposit Receipt of any Scheduled Bank of **Pay & Accounts officer NRSC, Hyderabad** (or) in the form of Bank guarantee issued by a scheduled bank. Earnest Money Deposit shall be valid for **180 days** from the due date of receipt of tenders. In case EMD in the form of DD is furnished, the same will be encashed immediately on opening of tenders and refund of EMD for unsuccessful tenderers will be made through Cheque / electronically by the Department.

b) The **MSME units claiming exemption of Tender cost/ EMD should submit MSME UDYOG ADHAR MEMORANDUM or registration certificate issued by District Industries Centre (DIC) / Khadi & Industries board (KVIB)/ Coir board / National small industries**

**commission (NSIC)/ Directorate of Handicrafts and handlooms or any other body specified by Ministry of MSME. The memorandum/certificate shall be valid as on due date / extended due date of the tender.**

5. Tenders will be opened at the Office of the Group Head/ Head, Construction and Maintenance Group/ Division on the stipulated date and time specified in Para 1 above.

6. a) Original instrument of EMD shall be submitted to the office of the Group Head, Construction and Maintenance Group on or before due date and time of opening of tender indicated in para 1 above. *If valid EMD is not received on or before due date and time of opening of tender, the tender offer shall be summarily rejected.*

b) The MSME units claiming exemption of Tender cost/ EMD should submit attested hard copy of MSME UDYOG ADHAR MEMORANDUM or registration certificate as indicated in para 4 (b) above. The hard copy of above memorandum / certificate shall be submitted to the office of the Group Head/Head, Construction and Maintenance Group/ Division on or before due date and time of opening of tender. *If hard copy is not received on or before due date and time of opening of tender, the tender offer shall be summarily rejected.*

7. On the due date of opening, the Technical & Commercial bid of those tenderers who furnished valid EMD only will be opened. On opening of Technical & commercial bid, further detailed scrutiny / evaluation will be carried out in two stages as below,

*Stage-1:* The documents furnished by the tenderers will be scrutinized in detail. Any tender, found as not fulfilling the eligibility criteria will be rejected at this stage and such offers will not be considered for further processing.

*Stage-2:* At this stage, the competency of the tenderers will be further evaluated by a Technical Evaluation Committee (TEC), including inspection of selected works carried out by tenderers. The Technical Evaluation format including the evaluation criteria is enclosed in the tender document.

**Only those bidders who satisfy requirements under Stage-1 will be eligible for evaluation process under Stage-2. The bidders who are finally shortlisted after the complete evaluation will be qualified for further participation in the tender.**

The price bid of only those tenderers who have been qualified during the scrutiny and technical evaluation will be opened separately on a specified date (with due intimation to the qualified bidders) and further processed, as per tender procedure/ stipulations.

**Note:** Any particular tenderer who has been technically evaluated by any of ISRO Centres in the past one year for any work of similar nature and magnitude and for same criteria of evaluation, such bidders will not be re-evaluated and the scores of the previous evaluation will be taken for the assessment of the eligibility for the present tender.

8. The contractor, whose offer is accepted, will be required to furnish **performance guarantee of 5%** (Five Percent) of the tendered amount within 15 days from the date of issue of letter of intent/ work order. This guarantee shall be in the form of Deposit at Call receipt/ Term Deposit Receipt of any Scheduled Bank issued in favour of **Pay & Accounts officer NRSC, Hyderabad** (or) in the form of Bank guarantee issued by a scheduled bank in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period specified including the extended period if any, the Earnest Money deposited by the contractor will be forfeited and letter of intent/ work order cancelled automatically without any notice to the contractor. The Earnest Money deposited along with tender shall be refunded only after receiving the aforesaid performance guarantee.

9. Intending tenderers may inspect the site before submitting the tenders, with the prior permission of **Group Head, CMG, NRSC**

10. The tender accepting authority on behalf of President of India is not bound to accept the lowest or any other tender and reserves the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.

11. The tender accepting authority on behalf of President of India also reserves the right to alter the scope/ or reduce quantum of work before issue of work order and the tenderer shall not have any claim what so ever on this account.

12. The tender accepting authority on behalf of President of India reserves the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.

13. Canvassing directly or indirectly, in connection with tender is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable for rejection. Issue of tender documents on the basis of the documentary eligibility alone will not make a tenderer eligible for participating in the bidding. The documents furnished by the tenderers will be subjected to verification subsequently by Department.

14. The tender accepting authority reserves the option to give preferences to the offers in accordance with the policies of the Government from time to time.

15. The contractor shall not be permitted to tender for works in the Division of that particular Centre of the Department responsible for award and execution of contracts for which his/her near relative is working. He/she shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any Gazetted Officer in the Department of Space. Any breach of this condition by the contractor would render him liable for rejection of tender or cancellation of contract.

16. The tender should be valid for **minimum period of 120 days** from the due date of receipt of the tender specified in Para 1 above. If any tenderer withdraws the offer within the validity period or makes any modifications in the terms and conditions of the tender which are not acceptable to the Department, the Government shall without prejudice to any other right or remedy, be at liberty to forfeit 50% (Fifty Percent) of the Earnest Money Deposit absolutely. Further, the tenderer shall not be allowed to participate in the re-tendering process of the work.

17. On concluding the tender, an agreement shall be drawn with the successful tenderer.
